  - a. The community is almost built out, only 3 lots remain
- VII. Water District Mark Petty
  - a. Timber Creek Estates has its own water rights to two wells.
  - b. The Board is all volunteers that must be registered Colorado voters, currently 2 seats open.
  - c. Currently the bonds that are scheduled to be paid off by 2030 could be paid off within the next 5 years.
  - d. The water district has never had bad water, the non-compliance violations that have occurred are due to not filing reports on time. The Board had to pay a \$4,000 fine to the state of Colorado.
  - e. A home can collect up to 50 gallons of rain water at a time.
  - f. The generator for the water pumps is in place for when the community loses power.
- VIII. Michelle Eddy report from the Town of Blue River:
  - a. The town continues to support any and all fire mitigation that can be done.
  - b. An Eagle Scout has made three benches for the town park.
  - c. Police Chief Ahmet Susic and the town are concerned with speeds in our community. They did do a speed study on Whispering Pines Circle this past summer but didn't find statistics that would warrant additional changes with enforcement. The HOA could do another speed study at their expense.

- d. The Town working with Colorado Department of Transportation (CDOT) has revised their plans regarding a chain up station in front of the town hall on Highway 9. In summary there will be a passing lane put in place that will be used as a chain up station when the need arises. There will not be any lights. This project probably won't occur until 2022.
- IX. Our Fire Captain Benedict reported that they continue to work with homeowners to create defensible spaces at each residence. There still a need to work with the US Forest service to remove fallen trees and extra fuel from the surrounding forest.
